## Request:

I write to make a freedom of information request concerning council tax.

1. Please supply a copy of your council's procedure for dealing with unpaid council tax, including a timeline of when bailiffs are involved and bankruptcy charges filed?

In accordance with the collection and debt strategy, bankruptcy proceedings will be considered on an individual basis.

All individual debts for each year are less than £5,000. Please note an individual may have had one or more accounts in a given billing period due to change of address.
