- 4. Where badges and plates have been **surrendered**, licences that have not expired can still be reviewed at a **licensing hearing**.

Information regarding surrender of pending investigation/review hearing

In the case of a surrender of plates/badges pending investigation, you understand that it is a voluntary surrender in order to assist the Police/Council investigation and in the interests of public safety. Should you not voluntarily surrender your badges/plates, you understand that the Council will organise an **immediate review** of your **licence** where it will consider the evidence as it is now, which may result in your badges/plates being suspended or revoked with immediate effect based on the evidence before the Council at the time of the review. If the decision at the licensing hearing is **not** to suspend or revoke your licence, then your badges/plates will be **returned**, however there will be **no refund of fees** during the voluntary surrender period.

Declaration

On returning the badges and/or plates in respect of the licence(s) as detailed above, I have read the above information and understand that the **licence is/are not valid** without the driver badge/licence plate.
