The Wolverhampton Local Plan will cover the whole of the administrative area of City of Wolverhampton Council, will set out where new housing and employment development and infrastructure investment will take place up to 2042, areas of the City where development will be restricted, and areas of importance which will be priorities for conservation and enhancement. The Plan will also include a set of 'policies' – the rules which are used to determine planning applications for a wide range of development proposals.
