The information provided below is for an illicit product not counterfeit. The term "Counterfeit" is generally used for mainstream brands which are usually trademarked and are then illegally copied to make a fake product look like the genuine thing. We use the term "illicit" a product that is counterfeit or non duty

Whilst tobacco and cigarettes can be counterfeited we can only really tell if this has happened for UK based brands. It would be impossible to tell if, for example, a non-duty paid Russian cigarette is also counterfeit.
