Children Missing from Education

Request:

1)

a) How many children were recorded as missing from education in the last 3 years (2014, 2015, 2016 to date). If possible can I have the figures broken down by academic year, or however you hold this information.

In answer to question 1a) please see table below.

Note that Wolverhampton Local Authority records CME data in academic years, e.g. 1/9/14 to 31/8/15 (2014/15) and 1/9/15 to date (2015/16). Of the total investigations there are cases of confirmed CME of children that are living in Wolverhampton and those that are not living in Wolverhampton.

The reasons given were:

- * Children were not allocated parental school preference initially
- * Family were new into city, awaiting a school placement.
- e) How many of the children in 1a) who have not been tracked down, have been removed from the schools admissions registers?

Please note that the children with unknown destinations have been removed from our system following all 'reasonable enquiries' in accordance with sections 8(1)(f)(iii) and 8(1)(h)(iii) of the Education (Pupil Registration) (England) Regulations 2006.

a) How many children under 16 who were in full time education have been removed from council records/ schools admissions registers in the last 3 years? 2014, 2015, 2016 to date?

Children removed from school registers: 2014/15 = 829 : 2015/16 = 708

b) Of those children under 16 removed from schools register, how many have a recorded destination/location?

2014/15 = 6682015/16 = 564

c) Of those children under 16 removed from schools register, how many are deemed children missing in education?

Of those without a destination did we investigate and deem CME: 2014/15 = 74 : 2015/16 = 49

3) How many investigations into cases of a child who has stopped attending schools have been completed to ensure that child is receiving a suitable education in 2014, 2015 and 2016 to date?

2014/15 = 161 2015/16 = 144
