The actual expenditure and income figures shown are classified as controllable. The term controllable in this context means that purely internal transactions within the Council, internal support service charges for example, have been excluded. The request asked for figures 'to date in 2015-16'. That financial year has now ended and figures provided are for a full year.

The income identified has been broken down into three categories:

- 1) Miscellaneous fees and charges;
- 2) Recharges to other local authorities; and
- 3) Cabinet Office grant applied in year.

There are no other income sources. The net expenditure resulting in each year has been funded by the City of Wolverhampton Council.

The budget figures shown represent the net budget allocated at the start of each financial year. In 2016-17 the net budget allocated has risen to £324,000.
