Wolverhampton City Council wishes to appoint a multi-supplier framework agreement to carry out and ensure timely completion of comprehensive and high quality assessments of prospective foster carers for presentation to the City Council's Fostering Panel.

All forms would need to be produced in accordance with the British Association of Adoption and Fostering's (BAAF) Form F and Guidance Notes.

In response to your request we can confirm that the tender followed an Open procedure and so there was no PQQ stage.

5 companies submitted bids.

3 were appointed to the framework: Core Assets Group Ltd Minster Social Work Ltd Sanctuary Personnel Ltd

2 were not appointed: H&I Social work Services Keys Family Network

The contract value in year to date is $\pounds 12,000 -$ information taken from Contracts Register.

Start date of the framework agreement was 1/4/2013. The initial period was to 31/3/2015. The framework was extended to 31/3/2016, and then subsequently extended again to 31/3/2017. The extension periods were provided for in the initial framework agreement.

No further extension periods apply and the framework agreement is being reviewed with a view to renewal.
