Request:

I am requesting disclosure of the following information under the Freedom of Information Act:

1. The number of people (excluding carers) who received council-funded adult social care services in 2013/14, broken down between age groups 18-64 and 65+ (full-year figure)
[There were 5,288 clients in receipt of council-funded adult social care services in 2013/14, of which 1,446 were aged between 18-64 and 3,842 were aged 65+.](#)
2. The number of people (excluding carers) who received council-funded adult social care services in 2014/15, broken down between age groups 18-64 and 65+ (full-year figure)
[There were 5,032 clients in receipt of council-funded adult social care services in 2014/15, of which 1,371 were aged between 18-64 and 3,661 were aged 65+.](#)
3. The number of people (excluding carers) who received council-funded adult social care services in 2015/16, broken down between age groups 18-64 and 65+ (full-year figure)
[There were 4,897 clients in receipt of council-funded adult social care services in 2014/15, of which 1,322 were aged between 18-64 and 3,575 were aged 65+.](#)
4. The number of people (excluding carers) who received council-funded community-based services each year in 2013/14, 2014/15 and 2015/16 respectively, each broken down between age groups 18-64 and 65+ (full-year figure)
[In the year 2013-14 there were 4,012 clients receiving community-based services, of which 1,236 were aged 18-64 and 2,776 were aged 65+.](#)
[In the year 2014-15 there were 3,726 clients receiving community-based services, of which 1,137 were aged 18-64 and 2,589 were aged 65+.](#)

In the year 2015-16 there were 3,686 clients receiving community-based services, of which 1,083 were aged 18-64 and 2,603 were aged 65+.

5. The number of people (excluding carers) who received council-funded residential care each year in 2013/14, 2014/15 and 2015/16 respectively, each broken down between age groups 18-64 and 65+ (full-year figure)
 In the year 2013-14 there were 1,617 clients receiving community-based services, of which 297 were aged 18-64 and 1,320 were aged 65+.

In the year 2014-15 there were 1,542 clients receiving community-based services, of which 295 were aged 18-64 and 1,247 were aged 65+.

In the year 2015-16 there were 1,502 clients receiving community-based services, of which 295 were aged 18-64 and 1,207 were aged 65+.

6. Please list the number of people (excluding carers) who received each separate type of council-funded community based service each year in 2013/14, 2014/15 and 2015/16 respectively, each broken down between age groups 18-64 and 65+ (full-year figure)
