## **Compensation to Pupils/Parents**

## **Request:**

Under the FOI Act could you please tell me how much your council has paid in compensation to pupils/parents on behalf of a school under your authority in the 2014, 2015 and 2016 calendar years.

If you can only provide the last three financial years, that is also acceptable.

Please breakdown the information clearly showing the school name, the month the payment was made, how much the payment was for and the reason for the payment - e.g. fell over running in playground.

In response to your request, please find our response below.

The Council has decided not to list the School Name as it has obligations to protect the personal information of individuals under the Data Protection Act. Therefore there is an exemption on disclosure of information which we feel is the personal information of identifiable individuals.

The Council believes that any detailed information, naming the School, would be personal data as defined by Section 1(1) of the Data Protection Act (DPA) as it relates to an identifiable individual and releasing this information to the wider world could identify the individuals concerned. Therefore the information you requested is personal data as described in Section 40(2)(a) of the FOIA.

Section 40(2) - Any information to which a request for information relates is also exempt information if –

(a) it constitutes personal data which do not fall within subsection (1), and

(b) either the first or the second condition below is satisfied.
