 We provide a carers short break Grant of £300 per family and direct payments are available for all services meeting an eligible need set out in the young person EHCP including Short Breaks
- 9. Do you provide a framework of approved Short Breaks providers?
 We tendered for providers to deliver 4 different types of community based services in 2016. Our Special schools also provide a range of short breaks and we tendered for a provider to build and deliver a small residential short breaks service in 2015.
- 10. Do parents/carers book Short Breaks provision via the council? It depends on the type of short breaks, some services are direct access and families can book direct with the provider once they have an allocation following as assessment. For the contracted services, Overnight short breaks are book via the social work team.
