Request:

Under the terms of the Freedom of Information Act I would like to request details relating to total spend on textbooks in your Local Education Authority.

In particular, I would like to request the following information:

 How much was spent on textbooks in total by a) primary schools and b) secondary schools in each of the last five financial years? In respect of your above question, it has been established after careful consideration that the Council does not hold the above information. Consequently, we are unable to provide any information relating to the above, and are informing you as required by Section 1(1) (a) of the Act, that states:

"Any person making a request for information to a public authority is entitled to be informed in writing by the public authority whether it holds information of the description specified in the request".

2. How much was spent in total on all classroom learning resources by a) primary schools and b) secondary schools, with an indication of what resources this would cover, in each of the last five financial years. With reference to the year 2016/17, it has been established after careful consideration that the Council does not hold this information as this is not yet available. Consequently, we are unable to provide any information relating to 2016/17, and are informing you as required by Section 1(1) (a) of the Act, that states:

"Any person making a request for information to a public authority is entitled to be informed in writing by the public authority whether it holds information of the description specified in the request".

- · achievement gifts and prizes awarded to pupils
- books (library and text books)
- charges for the school library
- classroom and learning equipment (excluding ICT equipment)
- curriculum transport, including minibus expenses such as maintenance, tax, fuel (excludes insurance)
- furniture used for teaching purposes
- pupil travel for work experience placements
- purchase, lease, hire or maintenance contracts of audio-visual or other equipment used for teaching
- reprographic resources and equipment used specifically for teaching purposes
- school trips and educational visits
- servicing and repairs to musical instruments and PE equipment used as part of the curriculum
- subscriptions, publications, periodicals and copyright fees associated with the curriculum, including sums de-delegated by the LA (not nationally administered licences purchased by the Secretary of State)
- teaching materials
- television licence fees used for teaching purposes
- payments to alternative provision services including pupil referral units (PRU), non-maintained special schools (NMSS), and independent schools
- primary school PIP examination costs
- payments made to students in receipt of the 16-19 Bursary Fund

And specifically excludes:

- curriculum ICT costs
- resources that are used for administrative purposes.

What was the total amount of funding provided for all proposes to a) primary and b) secondary schools in the Local Education Authority in each of the last five financial years and how many schools that funding related to. The table below details the capital expenditure invested in schools by the Local Authority using a combination of Capital Grants and Council Resources (including Capital Receipts and Borrowing).
