Domestic Violence

Request:

I'm writing to request the following information under the Freedom of Information Act, in annual data sets for each of the last ten years.

1) The number of specialist refuges for women/non-binary victims of domestic violence and their kin with specialist needs (BaMER, LGBT, disabled, those with mental health conditions, problematic substance users, older women/non-binary people) in each the council area, and the maximum capacity of these refuges, in FY2007/2008, FY 2008/2009, FY 2009/2010, FY 2010/2011, FY2011/2012, FY2012/ 2013, FY2013/2014, FY2014/2015, FY2015/2016 and FY2016/2017?

From 2007 to 7 December 2013, one service provider was contracted to provide five refuges and support a total of 46 women at any one time including providing specialist support to Asian and African-Caribbean women. The split of specialist/non-specialist support was determined by need and therefore unless it is assumed that all five refuges were specialist, it is not possible to give the number of specialist refuges or the total capacity.

Since 8 December 2013, all refuges have been generic and are required to provide specialist support as required, using five refuges with a maximum capacity of 73 women plus their children until 31 March 2015 and 50 women plus their children from 1 April 2015 to date.
