Could you then provide corresponding rows for:

- length of time it took to move the travellers on
- cost in legal fees to obtain and deliver directions to leave to travellers, and to
 obtain court date and summons to evict them
- cost of booking bailiffs and paying bailiffs to remove travellers
- cost of clean up after removal
- cost of target hardening/ improving defences to prevent travellers returning
- any additional costs

Could you also total the costs for each year and give the average number of time it took to move travellers on each year.
