# **Employment Support Services**

### Request:

We are interested in the provision of employment support for disabled people, and in particular that for people with a learning disability.

The information we would like to get is:

## Employment support commissioned and/ or provided by the local authority

 What employment support services does your local authority provide for people with a learning disability? Please include both provision that is run directly by your local authority or a provider commissioned by your local authority.
 Shropshire Enable

City of Wolverhampton Council commissioned Shropshire Enable to provide supported employment support for people with disabilities in November 2015.

### **Supported Internships**

Supported Internships are personalised study programmes for young people with learning difficulties and/or disabilities aged 16 to 24 with an Education, Health and Care Plan who want to move into employment and need extra support to do so. They are designed to enable young people with learning difficulties and/or disabilities to achieve sustainable paid employment by equipping them with the skills they need for the workplace. Delivery of the programme mainly takes place at an employer's premises through a 'train on the job' approach, with the support of a job coach.

Supported Internships are currently provided by City of Wolverhampton College, NOVA Training and Wolverhampton Vocational Training Centre.

# **Connexions**

City of Wolverhampton Council provides support to vulnerable young people at risk of not making a successful transition into education, employment or training (EET) through its Connexions Service (which is part of the wider Skills Service providing employability support to young people and adults.) Connexions is a targeted service working with young people from age 13 -19 and up to age 25 with a disability including learning difficulty/disability. Connexions provides careers guidance and practical support to young people to help them get into education, employment and training.

## **Black Country Impact**

City of Wolverhampton Council is a delivery partner for Black Country Impact which is funded by ESF and Youth Employment Initiative plus match funding from Black Country Talent Match and the Black Country LAs Impact - aimed at all 16 -29 year olds who are NEET including young people with disabilities. This is not specialist provision but can commission tailored support packages for individuals or groups.

### Wolves@Work

Job coaching and matching. Jointly funded by City of Wolverhampton Council and DWP and aimed at all 18 plus people who are job ready and want to work but need some additional support to get into the labour market including those with disabilities.

# **Individual Placement Support Service (IPS)**

The Individual Placement Support Service provides dedicated employment support to individuals experiencing mental health issues as a contributing factor to them being unemployed. The project also provides mentoring support to individuals whilst in work.

# **Community Skills and Employability programmes**

CWC co-ordinates support for adults who are furthest from the labour market including sector based programmes from community locations across the city in partnership with Wolverhampton Learning Platform, local work clubs and a range of key providers.

### Mind@Work

Mind@Work is an intensive programme of coaching, mentoring, training and support to equip individuals with the skills they need to enter volunteering, work experience and/or employment. The programme is tailored to the needs of individuals who experience stress or anxiety, providing coping strategies and confidence building alongside employability skills.

# **Shropshire Enable**

People who can be supported by the Supported Employment contract delivered by Shropshire Enable Supported employment

People who have a disability and are currently receiving a social care service from social work teams

People with a disability who need employment support to prevent them from becoming future social care clients ('Prevention customers')

•Disability' covers anyone with a physical or learning disability that has a substantial (taking longer than it usually would to complete a daily task) or long-term (12 months or more) negative effect on your ability to carry out normal daily activities and people suffering from a progressive condition (one that gets worse over time)

### <u>Criteria for Supported Employment</u>

- People who are unable due to their disability to independently access universal employment support services and or the work environment without additional support
- Have previously been on the caseload of local authority Adult Social Care services in the last three years
- A young person (16-25 years) who is or has previously been on the caseloads of local authority Children's disability services in the last three years or have an EHC plan
- A young person (16-25 years) who is or has previously been a customer of local authority Children's Services in the last three years
- Be a resident of Wolverhampton

### **Connexions Service**

Targeted service for young people at risk of becoming NEET or are NEET who are between age 13 – 19 or 20 up to 25 with disability or special educational needs residing in the city and or being educated in the city. Also,

Young people who have an EHCP maintained by Wolverhampton and being educated outside of the City. The Connexions Service will attend EHCP reviews and provide IAG services or liaise with the appropriate local service, depending on the circumstances, for example where a young person is placed outside of the city with no plans to return it may be more appropriate to bring in the expertise of local services to support the young person.
