Occasionally, individuals residing within a local authority, use their homes for "photographic shoots" i.e. their homes are used by commercial organisations to take photographs of equipment, furniture or modelling within a domestic setting. These are actual residential addresses, not business premises but nevertheless the residential owner occupier allows the use temporarily, on a day-to-day basis or otherwise for the use of these photographic shoots (still photographs) for financial reward of some kind i.e. possibly one off payment

Within your planning department can you please inform me whether:

- There is guidance for owner occupiers on what is permissible. If so, please
 provide me with appropriate copy of said guidance. This can either be an
