Request:

I am sending this request under the Freedom of Information Act.

I am seeking information about funding for the provision of short breaks from caring for carers of disabled children over the last few years and the next financial year.

 How much overall funding was provided for the provision of short breaks from caring for carers of disabled children, in accordance with The Breaks for Carers of Disabled Children Regulations 2011, in the (financial) years 2014/2015, 2015/2016, 2016/2017, 2017/2018 and what funding is allocated for the same purpose in 2018/2019?

 - a) Fully funded by the LA = 137
 - b) Jointly funded with a CCG/s = 4
- 6. Of the short breaks you jointly fund, has the CCG portion been reduced or withdrawn in the financial year:
 - a) 2016/2017 Unknown
 - b) 2017/2018 No reduction or withdrawn to knowledge
 - c) 2018/2019 No indication at this stage that these will be removed as all of the children are subject to continuing health care.
