Care Leavers Semi-Supported Accommodation

Request:

- How many care leavers or eligible young people 16 to 17 years are living within supported or semi supported accommodation in 2017/2018?
 As at 14 March 2018 = 15
- 2. How many care leavers or eligible young people 18-24 years are living within supported or semi supported accommodation?

 As at 14 March 2018 = 57
- 3. What is the weekly cost inclusive of support hours and accommodation for placing a 16 to 17 years within semi supported accommodation? Please provide minimum, average and maximum costs weekly. The Council has a block contract that consists of the average cost is dependent on need. Some young people require intense support and others require low level support. The City of Wolverhampton have a block contract with YMCA (commissioned provider) to support 16–25 year olds. This includes 32 units for high level support, 17 units for medium support, 13 units for low level support, 10 units for supporting lodging and 8 units for looked after children.
- 4. What is the weekly cost inclusive of support hours and accommodation for placing an adult 18 to 24 years within semi supported accommodation? Please provide minimum, average and maximum costs weekly.

- 5. What is the average weekly amount of support hours required by 16-17 year olds?
 Support hours can vary from 5 hours up to 24 hours per week due to young people being in different provisions and the level of support being determined by their individual needs.
- 6. How do I join the "regional framework for supported accommodation for 16-17 year old care leavers?

 The framework is commissioned regionally and providers would need to submit tenders.

- 12. Can you explain your commissioning process for private residential care providers/private supported accommodation providers? Do you spot purchase, have framework contracts/agreement or block contracts? For under 18's we access provision via the regional Supported Accommodation Framework

City of Wolverhampton Council also has a contract for provision of Young People Supported Lodgings and Housing Support and Social Inclusion and was subject to a full tender process to award the contract.

13. Do organisations need to go through the tendering process to accommodate care leavers/young people (16-24 years old) on a spot purchase basis? City of Wolverhampton Council use the contracted service for supported accommodation.

If the contracted service cannot accept the referral, placement requests are published on West Midlands Portal and spot purchase if there is no match.

14. What is the weekly cost for floating support for 16-24 year olds, living within a training flat?

The average cost for a worker is £29.03 per hour. Hours are variable depending on level of support required.
