## **Voids**

## Request:

1. What is the current level of retail voids in your council area?

Our business rates records, which include details of whether a property is occupied or empty, allow us to identify premises according to their valuation classification.

At July 2018 we had 208 empty properties which broadly fall into the category of retail. The response to question 2 provides details of the properties which have been included.

- 2. What percentage of these voids have been in the following categories:
  - A1. Shops (inc. retail sale of goods other than hot food)
  - A2. Financial and professional services
  - A3. Food and drink
  - o B1. Business (inc. offices)
  - C1. Hotels and hostels
  - o D2. Assembly and leisure (inc. cinemas, bingo halls)
  - Other, please specify

In respect of question 2, it has been established after careful consideration that the Business Rates section within City of Wolverhampton Council does not hold all of the above information as we do not hold all of the classifications you have listed above.

Consequently, we are unable to provide all of the requested information relating to the above, and are informing you as required by Section 1(1) (a) of the Act, that states:

"Any person making a request for information to a public authority is entitled to be informed in writing by the public authority whether it holds information of the description specified in the request".
