I am contacting you to request information regarding the street lighting in Wolverhampton.

Please find my specific questions below:

- How many street lights does your organisation take charge over? 30,042
- How many maintenance requests have you received regarding street lighting since January 2018?

- 3) How many maintenance requests did you receive regarding street lighting in the years 2017, 2016, 2015, 2014, 2013, 2012, 2011, 2010, 2009 and 2008? In response to question 3 regarding the years 2008 - 2015, Section 1 of the Freedom of Information Act 2000 places two duties on public authorities. Unless exemptions apply, the first duty at:
 - Section 1(1) (a) is to confirm or deny whether the information specified in a request is held.
 - The second duty at Section 1(1)(b) is to disclose information that has been confirmed as being held.

To explain further the Council's funding comes from various sources including: Government grants, non-Government grants, fees and charges, business rates and council tax. Council tax income is accounted for at a council wide total and not disaggregated to individual service level. It is therefore not possible to provide the level of detail
