The managing director's ward walks are working visits to the city's 20 wards. The purpose is to meet with councillors, local residents and businesses to understand key issues in each area and then – often working with partners – put in place quick and sometimes more sustainable solutions to those issues. The ward walks also support the new managing director's induction and provide an important opportunity for him to get to know local communities, support networks and the opportunities to work together to make a difference. This is increasingly important at a time when the council's diminishing resources mean that collaboration with local communities and groups will be critical to effective service delivery. The ward walks have generated a working action plan that currently has 232 actions to deal with local issues, 109 of which have been resolved.

Outstanding actions include those that are on a programme of works due to be completed in 2019-2020 or will be completed as part of projects that are already progress.
