Request:

Statutory duties for local authorities aligned to the Children Act 1989. Key performance indicators for Local Authorities

Document 1 - Promoting the education of looked after children-Statutory guidance for local authorities (July 2014):

- 1. Section 2, Page 5. Does the Virtual School in your authority have a robust procedure to monitor the attendance and educational achievement of looked after children (that includes eligible children) their authority looks after? Yes, the Virtual School Team requests attendance and attainment data from all schools termly. A database is regularly updated with this information. The 16+ EET Worker monitors progress of eligible children termly.
- 2. Section 5, page 6. What elements of looked after children's (and eligible children) attainment and achievement are reported through the authority's corporate parenting structures?
 End of key stage levels (core subjects at KS1/1 and 5+ GCSEs including English & maths at KS4), HE engagement, EET data for 16+. Attainment and attendance data is reported separately for in-city and out-of-city pupils, as well as for the whole cohort. We also compare attainment of boys and girls and other cohort characteristics.
- As of the date of this request, does the Virtual School in your authority currently have a strategy in place that outlines how the educational achievement of looked after children will be enhanced? Yes or no Yes.
- 4. Section 5, page 6. In the 2014-15 academic session what percentage of Personal Education Plans (PEPs) produced, have been assessed as high quality and effective?

 33%, although this was only based on the autumn term and an analysis from the spring term 2016 showed considerable improvement. Nevertheless a PEP improvement action plan is being formed to address this issue.
- 5. Section 7, page 7. In 2015 how many fostering providers did your authority

commission to deliver fostering services?

33 External Providers, and 2 Internal Providers, therefore 35.

6. Section 7, page 7, leading on from question 5, how many of those fostering providers does the authority have a robust evidence base on, that clearly demonstrates that they prioritise the educational achievement of looked after children?

As corporate parents we have responsibility for meeting all the needs of our LAC, and we have systems in place that review our children on a regular basis through application of professional social work procedures and multiagency review panels.

7. Section 12, page 9. In the 2014-15 academic session, what measures did the Virtual School use to assess the impact of Pupil Premium funding for looked after children?

A clear policy on PPG use has been issued to all schools and social care teams. Further guidance on appropriate use of the PPG has been provided by the Virtual Head. PPG has been repeatedly discussed by the Virtual Head at a termly Designated Teachers Forum. The Virtual School Team audits 50% of all PEP – at least one for each child – and follows up any issues with school and social worker. This includes data on how the PPG is utilised. Virtual School Team members are linked up with every Wolverhampton school and communicate with Designated Teachers regularly to ensure that appropriate education support (including PPG use) is in place and that good progress is being made. The VSH provides training to Designated Teachers, carers and social workers on correct use of the PPG and the Virtual School Team attend many PEP meetings (particularly for LAC who are disengaged or underachieving) and provide challenge & support to schools on this area.

8. Section 22, page 11. In the 2014-15 academic session, how many of the authority's looked after children (aged up to 17), (that were in education), were educated in an educational institution judged as outstanding or good by Ofsted?

80% (year 1 to year 11).

 We have established that the Council does not hold the above information in a reportable format. Thus we are unable to provide any information relating to the above, and are informing you as required by Section 1(1) of the Freedom of Information Act.
- 16. Section 42, page 15. In 2015 what number of the young people that entered the care of your authority and were assessed as needing support for their emotional well-being, received a therapeutic intervention from a registered medical practitioner? As question 15.
- 17. Section 42, page 15. In 2015 what number of the young people that entered the care of your authority, had their mental health assessed by a *registered medical practitioner* (a person qualified to assess mental health) as part of their *initial statutory health assessment?*None.
- 18. Section 42, page 15. In 2015 what number of the young people that entered the care of your authority, were assessed as needing support with their mental health?
 - We can confirm that following careful consideration, the Council regrets to inform you that it has decided not to disclose this information.

Information you have requested has been withheld from disclosure. The exemption engaged is Section 12 of the Freedom of Information Act 2000 (FOI).

Section 12 of the FOI exempts Public Authorities from providing information where the estimated cost of compliance exceeds the appropriate limit. Any estimate must be undertaken in accordance with the limits set in fees

regulations made under Section 12 (5) of the FOI.

These Fees Regulations (SI 2004/3244 Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations) allow for a refusal where the cost of compliance, for local authorities such as the Council, would exceed £450. As a guide, staff time to identify and extract this information is charged at a rate of £25 per hour.

In summary, we cannot easily gather this information via a report as it is not held centrally. In order to determine the information you have requested, we would need to manually interrogate various systems/files. This would be a manual exercise and as such we believe the aggregated time it would take to collate the information would be in excess of 18 hours (equivalent to a notional cost of £450).

 The number of LAC receiving CAMHS interventions in 2015 is 109.
- 21. In 2015, how much did the authority spend on CAMHs provision? The LA Funding for CAMHS is £520,552.
- 22. How does the authority assess the impact of the CAMHs interventions delivered?

 Impact of CAMHS intervention is done on an individual case basis through the monitoring of outcomes and regular health assessments, and in addition the work of the LAC CAMHS team is reported annually to the Corporate Parenting Board, and monitored via the CCG.
