Utility Asset Data

Request:

We are contacting you as we require information on what utility companies / statutory undertakers have assets within your area of jurisdiction.

Our business works in the interest of many clients gaining underground utility asset data for their perspective sites and we require the above information in order to maintain utility company plant protection and best practice standards.

Under Section 59 of the New Roads and Street Works Act 1991 (NRSWA), Local Authorities are required to "use their best endeavours to co-ordinate the execution of works of all kinds" and "protect the structure of the street and the integrity of apparatus in it". We are greatly appreciative of your assistance in that matter.

Please find below list as requested which has been redacted in respect of information relating to identities of third parties which the Council considers meets the definition for personal data set out in Section 1(1) of the Data Protection Act 1998 ("DPA") as:

"data which relate to a living individual who can be identified - (a) from those data, or (b) from those data and other information which is in the possession of, or is likely to come into the possession of, the data controller and includes any expression of opinion about the individual and any indication of the intentions of the data controller or any other person in respect of the individual"

The Council thus considers that the requested information is caught by the exemption to disclosure contained in Section 40 (2) of the Freedom of Information Act 2000 ("FOI") and the related first condition of Section 40 (3).

To explain further, a disclosure made under the provisions of FOI is judged to be a disclosure to the wider world and here the Council must consider disclosure of personal information in line with the provisions of the DPA.

In this instance it is judged that the personal information relating to third parties details are not for the wider disclosure purposes and that the individuals would not expect their details to be disclosed to the world-at-large.

Any disclosure of this information would be judged in this instance to breach DPA principles, notably the first principle – that of fair and lawful processing and the second principle-that of processing for specified and not-incompatible purposes.
