1.0 Description of Savings Proposal

Details of proposal:

Undertake an initial review of the service with planned removal of vacant posts delivered by April 2014.

How will savings be delivered:

Through a net reduction in employee resources through either VR applications and/or deletion of vacant postsand some potential reshaping of the employee delivery structures

Service Impacts:

- Significant reduction in non-statutory activities such as verge parking orders, travel planning and highway extinguishment procedures for third parties;
- Unable to provide informal transportation and highway advice to applicants for planning consent for minor development proposals;
- Support for special events outside normal office hours and support to Police for public events outside office hours reduced or withdrawn;
- Ability to attract income from Sunday working significantly reduced or lost and works needing to be undertaken during the normal working day with consequent impacts on road traffic;
- Availability of staff for public meetings etc. much reduced;
- NOTE: Ability to deliver the Transportation Capital Programme would be protected as far as possible and resources focused to facilitate this.
